## FEE SCHEDULE

Mediation services provided at \$500.00 per hour, which includes:

- Time spent at the mediation
- Preparation for the mediation
- Preparation of documents after the mediation
- Discussions and telephone conferences with all parties involved, before, during, or after the mediation

The following minimum charges apply:

- A minimum of 2 hours for half-day
- A minimum of 6 hours for full-day
- Additional time may be charged for any necessary preparation

The fee is to be split evenly between the parties

## CANCELLATION POLICY


For cancellations made within seven days or less of the scheduled mediation, a minimum fee of \$1500 for half day or \$3000 for a full day mediation will be charged to the party responsible for the cancellation. If both parties agree to the cancellation, the fee will be divided equally between them.
